SERVICE AGREEMENT BOND

For Post ID no 01:-

Selected candidates will be required to execute a Service Agreement Bond of ₹50,000/- for Gen/OBC(NCL) candidates & ₹25000/- for SC candidates for serving POWERGRID for a minimum period of 3 years after successful completion of training.

RELAXATIONS AND CONCESSIONS

- Reservation for SC/OBC (NCL)/PwD/Ex-Servicemen candidates shall be admissible as per Government of India Guidelines.
- Reservation/Relaxations/Concessions to Ex-service men will be subject to submission of Discharge certificate in prescribed format issued by a Competent Authority. For Ex-servicemen with a minimum of six months continuous service, the age relaxation is to the extent of period spent in service plus 3 years over & above the category relaxation.
- Reservation/ Relaxation for OBC (NCL) will be subject to submission of attested copy of OBC (NCL) certificate along with NCL declaration in the format prescribed by the Govt. of India for "Appointment in Central Govt. Posts" issued by the Competent Authority.
- Reservation/ Relaxation for SC candidates will be subject to submission of attested copy of SC certificate in the format prescribed by the Govt. of India for "Appointment in Central Govt. Posts" issued by the Competent Authority.
- Relaxation in Age (*to the extent of 10 years over and above the age limit prescribed in respective category*), Essential Qualifications & selection test marks shall be admissible for PwD candidates subject to the condition that their percentage of disability is not less than 40% and their claim to relaxations is supported by a Certificate of disability issued by a duly constituted Medical Board in prescribed format.
- Relaxations/Concessions for J&K domicile/victims of riots shall be admissible as per Govt. Guidelines.

SELECTION PROCESS

1. The Selection Process shall involve Objective Type Selection Test of two hours duration, to be attempted on Computer(i.e. Computer Based Test), consisting of two parts –
 - a) Part-I consists of Professional Knowledge Test with 120 questions having specific questions of Electrical discipline.
 - b) Part-II consists of Supervisory Aptitude Test with 50 questions on vocabulary, verbal comprehension, quantitative aptitude, reasoning ability, ability to determine data sufficiency, interpretation of graphs/charts/tables, numerical ability etc.
2. To qualify against unreserved vacancies, candidates have to score at least 40% marks in Selection Test with at least 30% marks in Part I and II separately. For reserved vacancies (i.e. OBC/SC/PwD(HH)/PwD(OH)), the qualifying criteria in Selection Test is 30% marks with at least 25% marks scored in Part I & II separately.
3. All questions shall carry equal marks. **Wrong answers would result in negative marks of 1/4.**
4. Final merit for selection for the subject post shall be decided based on marks secured by the candidates in Selection Test (with 100%weightage) i.e. there shall be no interview.
5. The applicants will have the option to appear for Selection Test in HINDI language also.
6. The Offer of Appointment shall be issued to the suitable candidates in the order of merit and based on the requirement. Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per POWERGRID Norms and Standards of Medical Fitness.
7. Center for the selection test shall be intimated separately to the applicants found eligible during preliminary scrutiny of application. The right to allocate center/venue shall be reserved by the Management.

HEALTH

Appointment of selected candidates will be subject to them having sound health & being found medically fit in the Pre-Employment Medical Examination to be conducted as per the Norms and Standards of Medical Fitness (Please visit **Careers section** → **Health** of our website for details of medical standards). No relaxation in health standard is allowed.

APPLICATION FEE & MODE OF PAYMENT

- ❖ After successful completion of online registration, candidates shall receive an email with details of their Login ID, Password and other information. A button shall be available on the login page which will guide the candidate to payment gateway. Candidate will be automatically directed to payment gateway website and return back to POWERGRID website automatically on completion of transaction.
